**L.B.S. History**

Founded by Melvin and Margaret Dickinson after their return from two years of study as Fulbright Scholars in Germany, the Louisville Bach Society's performed its first concert in 1964 and was incorporated in 1965. Since then, the Society has performed over three hundred concerts, all have been directed by Melvin Dickinson and accompanied by Margaret Dickinson (who also serves as rehearsal accompanist. During the 2006-2007 season, the LBS produced locally four major classical choral music subscription concerts, each preceded by a lecture on the concert theme and repertoire., and the annual *Messiah* performance. In order to expose the region to fine choral music, every year the Society takes its programs on tour throughout Kentucky.
